ASSIGNMENT OF PURCHASERS' INTEREST

recorded March 21, 1977, in Vol. M-77 at page 4640 of Klamath County, Oregon,
Deed Records, wherein James E. Chaney and Wilda L. Chaney agreed to sell and
the Assignors agreed to purchase the property in Klamath County, described as
follows, to wit:

The following described real property is situated in Klamath County, Oregon.

Beginning at an iron pin which lies North 0°51' West along the 40 line a distance of 462.3 feet, and North 89°09' East, a distance of 262.2 feet, and South 46°09' East, a distance of 428.4 feet from the iron axle which marks the Southwest corner of the NE\(\frac{1}{2}\)SW\(\frac{1}{2}\) of Section 1, Twp. 39 S., R. 9 E.W.M., in Klamath County, Oregon; and running thence: Continuing on South 46°69' East a distance of 129.4 feet to an iron pin; Thence, North 43°51' East, a distance of 384 feet to an iron pin on the Southerly right of way line of the Klamath Falls-Lakeview Highway, which is 30 feet, measured at right angles from the centerline; Thence, North 46°09' West, a distance of 129.4 feet along said right of way line to an iron pin; Thence, South 43°51' West, a distance of 384 feet to the Point of Beginning.

EXCEPTING THEREFROM that Portion conveyed to the State of Oregon, by and through its State Highway Commission, recorded July 5, 1972, in Volume M72, at page 7243, Microfilm Records of Klamath County, Oregon.

Assignors further covenant and agree to and with the Assignees that said Agreement is a good, valid, and existing contract; that there remains unpaid thereon no more than the sum of \$112,012.60, with interest thereon at the rate of 9% per annum from August 15, 1978; that said Contract is not in default and that Assignors have good right to assign the same as aforesaid.
