KNOW ALL MEN BY THESE PRESENTS, That CLIFFORD J. SHUCK and HELEN SHUCK, husband and wife

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by PATTY COLLINE MILLETT, the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 10 and the Southeasterly 15 feet of Lot 11 in Block 17 of INDUSTRIAL ADDITION to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon. The whole being a rectangular piece of land 40 feet wide and 115 feet long, facing 40 feet on East Main Street.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances 1. Taxes for the fiscal year 1978-79, a lien, but not yet due and payable. 2. Trust Deed in favor of Security Savings and Loan Association, recorded in Volume M76, page 19231, which the grantees herein agree to assume and pay according to the terms contained therein. and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$24,000.00. However, the actual consideration consists of or includes other property or value given or promised which is the whole part of the consideration (indicate which).
