            ) FINDINGS OF FACT AND ORDER

8           A hearing was held in this matter at Klamath Falls,  
9           Oregon, on August 9, 1978, pursuant to notice given in conformity  
10          with Ordinance No. 35, Klamath County, before Klamath County  
11          Hearings Officer, Jim Spindor. The applicant was present. The  
12          Klamath County Planning Department was represented by Carl Shuck.  
13          The Hearings Reporter was Isabel Rodriguez.

14          Evidence was presented on behalf of the Department and  
15          on behalf of the applicant. There were no adjacent property  
16          owners present who stated they had objections to the proposed  
17          Variance requested by the applicant.

26          The hearing was then closed and based upon the evidence  
27          submitted at the hearing, the Hearings Officer made the following  
28          findings of fact:

1       FINDINGS OF FACT:

- 2       1. There are exceptional and extraordinary circum-  
3       stances which apply to this property that generally do not apply  
4       to other property in the area in that the subject lot is narrower  
5       than any of the surrounding lots in the area.  
6       2. The granting of this Variance is necessary for the  
7       preservation and enjoyment of the applicant's right to have a  
8       deck built on the existing hotel.  
9       3. No one testified in opposition to this Variance  
10      and there has been no evidence to suggest that it would have any  
11      detrimental effect on the public health, safety, or convenience  
12      of welfare.  
13       4. The requested Variance is the minimum Variance that  
14      will alleviate the hardship since the deck has already been  
15      constructed.

16       The Hearings Officer, based on the foregoing Findings  
17      of Fact, accordingly orders as follows:

18       That real property described as the  
19      "parcel of land approximately 300  
20      feet by 15 feet in size and  
21      generally located on the east  
22      side of State Highway 97 between  
23      Second Street to the north and  
24      First Street to the south and  
25      more particularly described as  
          situated in Lot 1 through 6,  
          Block 1, Section 21, Township  
          27 South, Range 9 East of the  
          Willamette Meridian, Klamath  
          County, Oregon"

26       is hereby granted a Variance in accordance with the terms of the  
27      Klamath County Zoning Ordinance No. 17 and henceforth the side  
28      yard setback requirement on the east side of the hotel will be

1 reduced from 70 feet to 50 feet based on the above-mentioned  
2 findings of fact.
