8 a Hearing was held in this matter at Klamath Falls,
9 Oregon, on August 9, 1978, pursuant to notice given in conformity
10 with Ordinance No. 35, Klamath County, before Klamath County
11 Hearings Officer, Jim Spindor. The applicant was present. The
12 Klamath County Planning Department was represented by Carl Shuck.
13 The Hearings Reporter was Isabel Rodriguez.

14 Evidence was presented on behalf of the Department and
15 on behalf of the applicant. There were no adjacent property
16 owners present who stated they had objections to the proposed
17 Variance requested by the applicant.

18 The following Exhibits were offered, received and made
19 a part of the record:

1 The hearing was then closed, and based upon the evidence
2 submitted at the hearing, the Hearings Officer made the following
3 findings of fact:

4 FINDINGS OF FACT:

5 1. There are exceptional and extraordinary circum-
6 stances which apply to the applicant's property that do not
7 apply to other property owners in the area, and that is that the
8 realtors have placed this mobile home on the property in its
9 present position and it would cost a substantial amount of money
10 to move it.

11 2. The granting of the Variance is necessary for the
12 preservation of the applicant's right to have this mobile home
13 remain where it is; which is a right possessed by other property
14 owners in the area.

15 3. No one testified in opposition to the Variance, and
16 there was no evidence that the granting of this Variance would in
17 any way be detrimental to the public health, safety, and welfare.

18 4. The requested Variance is the minimum Variance
19 which would alleviate the hardship in question; in which any
20 movement of the mobile home would create a hardship.

21 5. The requested Variance will not allow use of the
22 property for a purpose which is not authorized in the zone.

23 The Hearings Officer, based on the foregoing Findings
24 of fact, accordingly orders as follows:

25 That real property described as the

26 parcel of land approximately on
27 the northern portion of Lot 62,
28 lying westerly of Main Street and
approximately 50 feet north of
Third Street and approximately
130 feet south of Second Street,
Port Klamath, Oregon, and more

is hereby granted a Variance in accordance with the terms of the
Klamath County Zoning Ordinance No. 17 and henceforth the rear
yard setback requirement will be reduced from 70 feet to 7 feet
6 inches and the side yard setback requirement will be reduced
from 70 feet to 10 feet.
