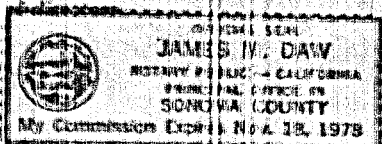
The true and actual consideration and for this transfer, stated in terms of dollars, is \$ 34,000.00.

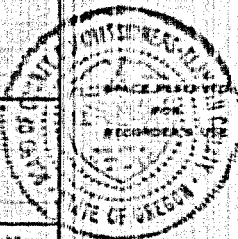
