KNOW ALL MEN BY THESE PRESENTS, That Mabel O'Brien, formerly Mabel Shadduck and Phillip O'Brien, wife and husband hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Jeld-Wen, inc., hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lots Eleven and Twelve in Block 7, Buena Vista Addition to the City of Klamath Falls, Oregon, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

Subject, however, to the following:

1. Taxes for 1978-1979 are a lien, but not yet payable.
2. Subject to the easements, restrictions, reservations, and right-of-ways.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever. And said grantor hereby conveys to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as noted of record as of the date of this deed and those apparent upon the land, if any, as of the date of this deed,

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$17,562.00. However, the mutual consideration consists of one thousand dollars in value given or promised which is paid in full. (The word "which" between the words "given" and "promised", if not applicable, should be deleted. See ORS 93.030.)

In witness whereof, this deed and charter shall be implied to make the provisions herein apply equally to corporations and to individuals.
