A parcel of land situated in Section 31, T39S, R8E, WM, more particularly described as follows:

Beginning at a point on the Southeasterly right of way line of the old county road known as "Pickett Road" from which the corner of lot 1, Block 1, Klamath River Acres bears the following two bearings and distances: N46°02'47"E 536.13, N46°03'18"W 251.18 feet, thence from said point of beginning Southwesterly along the Southeasterly right of way line of said Pickett Road 737 feet more or less to the Northerly line of the Weyerhaeuser Timber Company Private Logging Road, thence Southeasterly along the Northerly line of said Weyerhaeuser Timber Company Private Logging Road 183 feet more or less to the Northwesterly right of way line of the Klamath Falls-Ashland Highway (Highway 66), thence Northwesterly along the Northwesterly right of way line of the Klamath Falls-Ashland Highway (Highway 66) 688 feet more or less to a point that is located S50°02'00"E 361.12 feet from the point of beginning, thence N50°02'00"W 361.12 feet to the point of beginning, containing 4.9 acres, more or less.
