being about 24 thousand board feet more or less, which were obtained, handled, manufactured and/or transported in Klamath and Lake County, State of Oregon, are marked thus NV-3, branded with yellow paint on end and are now lying in the approximate area of the summit of Quartz Mountain, just South of Oregon Highway 140 (Spillway Sale) for labor performed upon and assistance rendered in handling said felled and decked logs, prior to hauling

The name of the owner of the above described timber and/or wood products is either Alpine Veneer or Crone Trucking. Following is a description of the said labor performed and the said assistance rendered at the request of said owner in the trade as "bumping knots" and work as a "Deck man."

The date of the furnishing of said labor and assistance was August 23, 1978; 60 days have not elapsed since the date just mentioned.



The foregoing Lienors and Woodworkers Lien is affixed to the Section 17 of Chapter 443, Oregon Laws 1975; Section 21 of said chapter provides in part:

"(1) A person claiming a lien created by section 18 to 20 of this Act shall file a written notice of claim of lien with the recording officer of the county where the work or labor rendering of the debtor, or part or parts, was done, or where the principal place of business not later than 60

Sections 23 and 24 of said Chapter 443 provide:

"Section 18. The recording officer of the county shall record the notices filed under section 21 of this Act in a book kept for that purpose and called 'Record of Liens upon chattels.'

"Section 19. When a lien claimant files a notice of lien as herein required by section 21 of this Act, he shall send forthwith a copy of the notice to the owner of the chattel for his signature and the recording officer shall record the signed notice to him at his last-known address."
