KNOW ALL MEN BY THESE PRESENTS, That Halin Park and Recreation District, an Oregon Municipal Corporation

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by City of Halin, an Oregon Municipal Corporation, hereinafter called the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

A tract of land for the placement of a water tank for the City of Halin, situated in the NE 1/4 of Section 16, T. 41 S., R. 12 E., W. 1/2, Klamath County, Oregon, more particularly described as follows:

Beginning at the most southerly corner of D.V. 305, Page 225, as marked by a cyclone fence corner, said corner being S27°23'33"W 1397.12 feet (S26°31'30"W 1397.9 feet by said deed volume); thence N40°08'00"W (N41°00'00"W by said deed volume) 50.00 feet to the most westerly corner of said deed volume and being the true point of beginning of this description; thence N40°08'00"W 50.00 feet to a 1/2-inch iron pin; thence N40°08'00"W 50.00 feet to a 1/2-inch iron pin; thence S40°01'30"E 50.00 feet to the most northerly corner of said deed volume; thence S40°01'30"E to the true point of beginning, containing 2500 square feet, with bearings based on rechecked survey No. 2539, as recorded in the office of the Klamath County Surveyor.

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except easements or restrictions of record, common to the area or apparent on the face of the land

and that

grantor will warrant and defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
