RELINQUISHMENT OF FEDERAL GEOTHERMAL LEASE IN WHOLE

Hunt, and covering the following described lands situated in Klamath County, State of Oregon

AND WHEREAS NELSON BUNKER HUNT

WHEREAS, NELSON BUNKER HUNT now desires to surrender to the United States of America, pursuant to the right of surrender, contained in said lease, all of the above described lands.

NOW, THEREFORE, for and in consideration of the premises, the undersigned, NELSON BUNKER HUNT, the present owner of said lease, does hereby surrender, release, assign and relinquish to the United States of America all of his right, title and interest in and to the lands described above.
