Ohlund, husband and wife, the grantor, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lot 25, Block 1, RAINBOW PARK ON THE WILLIAMSON, according to the official plat thereof, SUBJECT TO: Public rights in Williamson River; easements and rights of way and of record; Reservations, restrictions and conditions shown on the plat and in the Dedication of Rainbow Park on the Williamson; and to Declarations of Conditions and Restrictions dated September 9, 1964 and recorded September 11, 1964 in Vol. 356 at Page 116 of Klamath County, Oregon Deed Records, which said Conditions and Restrictions Vendees take subject to and commit and agree to fully observe, perform and comply with and which shall be appurtenant to and run with the premises herein sold;

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever. And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor as lawfully entitled in fee simple of the above granted premises, free from all encumbrances, except any current taxes due, easements of record and those apparent on the land,

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
