the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

All that part of the SW¹/₄SW¹/₄ of Section 7, Township 40 South, Range 10 East of the Willamette Meridian, lying Northeasterly from the Dalles-California Highway, in the County of Klamath, State of Oregon.
Subject to reservations and restrictions of record and easements and rights of way of record and those apparent on the land.
Subject to regulations, including levies, assessments, water and irrigation rights and easements for ditches and canals, of Klamath Irrigation District.
Subject also to special tax assessment for farm use, and if change in use disqualifies the property for future farm use taxation, the grantee assumes and agrees to pay all such taxes.

To Have and to hold the same unto the said grantee and grantee's heirs, successors and assigns forever.
And said grantor hereby covenants to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as hereinabove set forth.

grantor will warrant and defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whatsoever, except those claiming under the above described encumbrances.
