KNOW ALL MEN BY THESE PRESENTS, That FIRST NATIONAL BANK OF OREGON, a national banking association, TRUSTEE, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto TIENG T. SANGRAN hereinafter called grantee, and grantee's heirs, successors and assigns all of that certain real property with the improvements, hereditaments and appurtenances thereto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Free and clear of all liens and encumbrances except restrictions and easements of record and except any lien or encumbrance caused or created by the Not Vendor.

To Have and to Hold the premises unto the said grantee and grantee's heirs, successors and assigns forever.
