KNOW ALL MEN BY THESE PRESENTS, That FIRST NATIONAL BANK OF OREGON a national banking association, TRUSTEE hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto ELLIS RAY HELMS & MARY ALYCE HELMS, husband and wife hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

Lot Fifteen (15), Block Eleven (11), of SUN FOREST ESTATES, Tract 1060, as shown by Map on file in the office of of the County Recorder.

Free and clear of all liens and encumbrances except restrictions and easements of record and except any lien or encumbrance caused or created by the Lot Vendee.

And the grantor hereby covenants to and with the said grantee and grantee's heirs, successors and assigns that said real property is free from encumbrances created or suffered thereon by grantor and that grantor will warrant and defend the same and every part and parcel thereof against the lawful claims and demands of all persons claiming by, through, or under the grantor.
