THEREFORE, in consideration of the Lender's agreement to make such loan to the Borrower, the Government hereby (1) consents for the Borrower to obtain said loan from the Lender for such purposes, and (2) agrees to and hereby subordinates in favor of the Lender and his successors and assigns its liens or security interests created or evidenced by the above-described instrument(s) insofar as they cover the following described property: Beginning at the Northeast corner of Section 2, Township 41 South, Range 10 East, W. M.; thence running South 29.37 chains; thence West 36.60 chains; thence North 29.37 chains to the North line of said Section 2; thence East along the North line of said Section 2, a distance of 36.60 chains to the point of beginning, excepting such portion of the above described land, if any, as may have been heretofore conveyed to the U.S.A. by deed recorded in Vol. 111, page 187, Deed records of Klamath County, Oregon.

This subordination is limited to the amount actually loaned by the Lender to the Borrower for the foregoing purposes, but shall not exceed \$ 19,024 plus interest.

No member of or delegate to Congress shall be admitted to any share or part of this Agreement or to any benefit that may arise thereupon.
