CERTIFICATE OF WATER RIGHT

This Is to Certify, That WEYERHAUSER COMPANY

Return
 of Box C, Tacoma, State of Washington, 98401, has made proof to the satisfaction of the Water Resources Director, of a right to the use of the waters of Well No. 4

a tributary of Klamath River for the purpose of manufacturing and mill domestic use

under Permit No. G-5405 and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 13, 1971

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.6 cubic feet per second, being 1.3 c.f.s. for manufacturing, and 0.3 c.f.s. for mill domestic

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, Section 18, T. 39 S., R. 9 E., W. M., 400 feet South and 500 feet East from the W $\frac{1}{4}$ Corner, Section 18

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ----- of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:
