 - The Borrower sells, rents or fails to occupy the Property as his or her permanent and primary residence; or а.
 - The Borrower fails to abide by the agreements contained in the Affidavit, or if the Lender or the Division (Housing Division, Department of Commerce, State of Oregon) finds b. any statement contained in the Affidavit to be untrue.
