THIS MATTER came on before the above-entitled Court on the 19th day of April, 1978, petitioner appeared in person and by Charles R. Speight appearing for Marvin J. Hollingsworth, her attorney. Respondent did not appear and was found in default.

The Court finding that irreconcilable differences existing between the parties have caused the irremediable breakdown of the marriage making the continuation of the marriage impossible, and that the parties were married on March 21, 1965, in Reno, Nevada, and that three children were born during this marriage, namely: WAYNE FOSTER, born October 16, 1966  
ALICIA FOSTER, born October 24, 1967  
JAMES FOSTER, born June 21, 1969.

IT IS HEREBY ORDERED AND DECREED THAT:

The marriage of the parties is hereby dissolved and said dissolution is finally effective June 19, 1978.

Petitioner is awarded custody of the three minor children, WAYNE FOSTER, born 10-16-66, ALICIA FOSTER, born 10-24-67 and JAMES FOSTER, born 6-21-69, subject to the right of reasonable and seasonable visitation privileges of respondent.

## II.

Respondent is hereby required to pay the sum of \$100.00 per month per each child or a total of \$300.00 per month as a contribution to the support of the three minor children of the parties, said payments to be paid directly to the Department of Human Resources, Support Unit, P. O. Box 2506, Salem, Oregon 97308, in the form of money order or certified check, said support payments shall commence May 1, 1978, and continue until each child shall attain the age of majority, marries, becomes emancipated or so long as each child remains a full-time student up to the age of twenty-one (21).

## III.

The property of the parties is awarded as follows:

1. The residence of the parties, located at 2440 Vine, Klamath Falls, Oregon, is hereby awarded to the respondent, free and clear of any right, title or interest of the petitioner.

2. Each party is awarded an equal amount of the household furniture and furnishings.

3. Petitioner is awarded the 1973 Chevrolet Chevelle, free and clear of any right, title or interest of respondent.

4. Respondent is awarded the 1976 Ford pickup truck, free and clear of any right, title or interest of petitioner.

5. Petitioner is hereby awarded any and all interest in and to the parties' savings account on deposit at the Investors Mortgage Company, Stayton, Oregon, in the approximate amount of \$26,000.00.

## IV.

Petitioner is hereby awarded judgment against the respondent for reasonable attorney fees in the amount of \$300.00, plus her costs and disbursements.

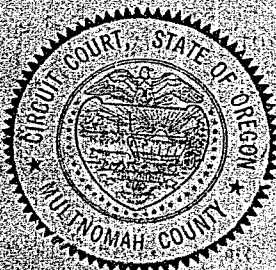
