KNOW ALL MEN BY THESE PRESENTS, That Albert LeRoy Morehouse, hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Albert LeRoy Morehouse and Jody M. Morehouse, husband and wife, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit:

A parcel of land situated in the NE $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 25, Twp. 39 S.-R. 7 EWM, more particularly described as follows:

Beginning at an iron pipe on the East line of Section 25, Twp. 39 S.-R. 7 EWM, from which the East quarter corner of said Section 25 bears North 562.5 feet distant; thence South along said East line of said Section 25, 622.3 feet to an iron pipe; thence West 490.0 feet to an iron pipe; thence North and parallel to the East line of said Section 25 a distance of 622.3 feet to an iron pipe; thence East 490.0 feet, more or less, to the point of beginning, containing 7.00 acres, more or less;

Also, an easement over a 30 feet wide strip of land for an access road to the above-described property, the centerline of which is more particularly described as follows:

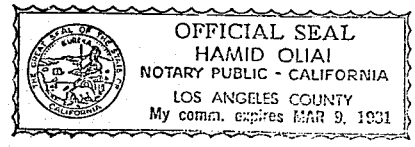
