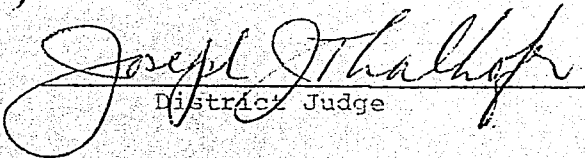
Upon the petition of Paul Yager for administration of the above
