SOL. *KNOW ALL MEN BY THESE PRESENTS: The undersigned, hereinafter called the claimant, did on the 12th day of March, 1978, enter into a contract with the owner of the improvement named below, for the performance of labor, transporting or furnishing materials to be used in or renting equipment used in the construction of said improvement known as a personal dwelling for Rex Julian.

*said improvement is situated upon certain land in the County of Klamath, State of Oregon, (which

The name of the owner or reputed owner of said land is Rex Julian; the name of the owner or reputed owner of said improvement is Rex Julian; the person or persons just named, at all times herein mentioned, had knowledge of the construction of said improvement. Claimant was employed to furnish said labor, ~~material and equipment~~ and to perform said contract by the said owner of said improvement. Claimant commenced his performance of said contract on March 23, 1978, provided and furnished all labor, ~~material and equipment~~ required by said contract and actually used in the construction of said improvement and fully completed his said contract on October 11, 1978, after which he ceased to provide labor, ~~material and equipment~~ for said improvement; Claimant ceased to provide further labor due to owner's failure to pay. ^{and deducting all just credits and offsets to-wit.}
