Subject to all encumbrances, restrictions, reservations, and rights-of-way of record and those apparent upon the land.

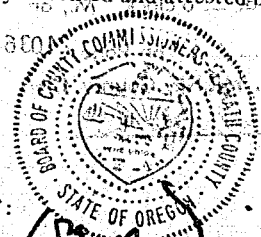
