FINDINGS OF FACT:

3 1. The site is adequate in size and shape to house the proposed activity and fits in with the neighborhood as is 4 shown by the fact that there are other mobile homes in the area. $\mathbf{5}$ 6 2. The site has adequate access to the streets and 7 highways to carry the traffic flow generated by the proposed use. 8 з. There would be no adverse affect on the abutting 9 property owners, nor did anyone testify in objection to the 10 granting of the permit. 11 4. The granting of this permit is consistent with the 12 goals of the LCDC. 13 5. The applicant is required to put in an adequate driveway to serve said mobile home. 14 The Hearings Officer, based on the foregoing Findings 15 16 of Fact, accordingly orders as follows: 17 That real property described as the 18 "parcel of land 71 feet by 135 feet or 10,125 square feet in size, generally located on the east side of Etna Street, approximately 136 feet south of Frieda 19 20Street and approximately 370 feet west of Gary Street and more particularly 21 described as Tax Lot 7501, Lot 11 of Empire Tracts, Klamath County, Oregon" 22 is hereby granted a Conditional Use Permit in accordance with the 23 terms of the Klamath County Zoning Ordinance No. 17 and hence-24 forth will be allowed the placement of a mobile home on the 25 January 27 subject property.
