The site is adequate in size and shape to house the proposed activity and fits in with the neighborhood as is 4 shown by the fact that there are other mobile homes in the sur-5 rounding area. 6 7 The site has adequate access to the streets and 2. 8 highways to carry the traffic flow generated by the proposed use. 9 3.
