Also, Robert F. Parker and Golda E. Parker, husband and wife hereby grants to adjoining property owners an easement for ingress and egress over the North 100 feet of the East 100 feet of the N $\frac{1}{2}$ NW $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 27, Township 34 South, Range 7.
