EASEMENT AND WATER USE AGREEMENT.

THIS AGREEMENT AND GRANT OF EASEMENT Made and entered into this u day of August, 1978, by and between LILLIE M. LEWIS, hereinafter called Grantor, and RAYMOND E. BLANCHETTE and SANDRA BLANCHETTE, hereinafter called Grantee;

WITNESSETH:

WHEREAS, The Grantor is the owner of Lot 28, First Addition to Algoma according to the official plat thereof on file in the Office of the County Clerk for Klamath County, Oregon, upon which said Lot is situate a domestic well; and

WHEREAS, The Grantees, Raymond E. Blanchette and Sandra Blanchette are the owners of Lot 26, First Addition to Algoma, according to the official plat thereof on file in the Office of the County Clerk of Klamath County, Oregon; and

WHEREAS, By oral agreement, the Blanchette property has been furnished with water from the domestic well on the Lewis property and the parties now wish to reduce such agreement and easement to writing, Now, Therefore,

The Grantor, for and in consideration of the sum of not less than \$7.00 per month, does by these presents grant, set over and convey unto the Grantees, their heirs, personal representatives and assigns, the right to the use of the water of the domestic well as above described, and the Grantor does further grant, set over and convey unto the Grantees, an easement over the strip of land where the pipe is now located, and the Grantees shall have the right to maintain said pipe line from the boundary of Lot 26 to the pump on the well, at Grantees' own cost and expense.

As a further consideration, Grantees agree to pay the proportionate share of any repairs, or pump replacement, made necessary by the use of said well.

This agreement shall be perpetual, or until such time as a domestic water supply is furnished from another source acceptable to the Veterans Affairs Administration of the State of Oregon.

TO HAVE AND TO HOLD The above described easements unto the Grantees, their heirs, personal representatives and assigns forever.
