

Contributions to Employee Benefit Plan: Oregon Laborers - Employers Trust Funds

KNOW ALL MEN BY THESE PRESENTS, That the Trustees of the Oregon Laborers - Employers Health and Welfare Trust Fund, the Oregon Laborers - Employers Pension Trust Fund, the Oregon Laborers - Employers Vacation Fund, the Oregon and Southwest Washington Laborers Training Trust Fund and the Oregon Laborers - Employers Construction Industry Advancement Fund, or the successors thereof, through the undersigned Trust Administrator, claim a Construction Lien against real property identified as follows:

1. At the special instance and request of Fred Owens Masonry, employees, whether Union or non-union, as defined in and covered by the Master Labor Agreement currently in effect, at the time of the performance of the employee's work, between the Oregon Southern Idaho & Wyoming District Council of Laborers and the following associations: the Associated General Contractors of America, Inc., Heavy Division, Building Division, Home-builders, Concrete Contractors Associations, Plastering Contractors Associations, Mason Contractors Association, and any other associations that became signatory to the Laborers Agreement, performed labor in the construction, alteration and/or repair of that certain building and/or improvement located upon certain lands situated in the County of Klamath, State of Oregon, and described as follows:
A tract of land situated in Lot 1, Block 4, Tract 1080 Washburn Park. Beginning at the Northeast corner of Lot 1, Block 4 of said Tract 1080; thence South 0°14'05" West along the East line of said Lot 1, 425.00 feet; thence North 89°25'10" West 410.89 feet to a point 200.00 feet from the West line of said Lot 1; thence North 0°09'48" East parallel to the West line of said Lot 1, 425.00 feet to the North line of said Lot 1; thence South 89°25'10" East 411.42 feet to the point of beginning containing 4.01 acres with bearings based on the recorded plat of said Tract 1080.

2. At all times that said employees commenced to perform said labor, Pacific Northwest Bell Telephone Co., was the owner or the reputed owner of the above-described land and the building and improvements thereon and had knowledge of and consented to, the construction, alteration and/or repair of said building and/or improvement.

3. As a result of the labor performed or the work done by said employees, contributions became due on or about October 20, 1978 to the aforesaid Trust Funds.

4. The following is a true statement of the Trustees' demand, after deducting all just credits and offsets:

The Trustees, through the undersigned, claim a lien for the total amount of \$3,063.56 listed above, upon the building and/or improvement hereinbefore described and upon the land upon which said building and/or improvement is located together with a convenient space about the same, or so much as may be required for the convenient use and occupation thereof, to be determined by the judgment of the Circuit Court at the time of the foreclosure of this lien.

6. The statutory time in which the Trustees have to make and file this claim of lien, on said property, with the Court Clerk of the County in which said land is situated, has not expired; sixty (60) days have not elapsed.

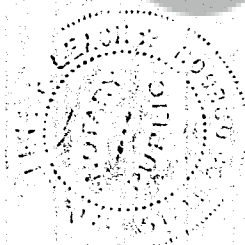
