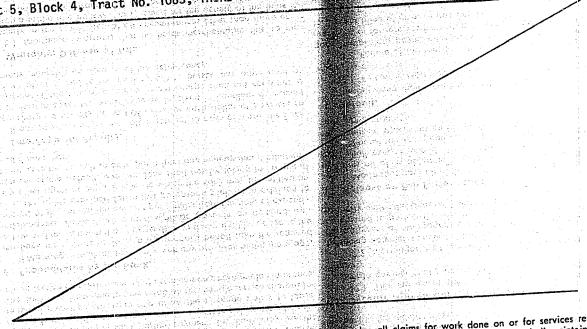

dxes 11.1 Mortgagor shall not, without the prior written consent of the Bank, transfer Mortgagor's interest in the Froperty, whether or not the transferee assumes or agrees to pay the Indebtedness.
