the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Government Lots #1, #2, #7, #8, #10 of Section 14, Township 36 South, Range 10 East of the Willamette Meridian, SAVING AND EXCEPTING from said lot 10, those portions deeded in Deed Volume 219 at page 493 and in Deed Volume 335 at page 316. ALSO EXCEPTING that portion conveyed to Klamath County for Sprague River Highway described in Deed Volume 85 at page 618. SUBJECT TO: Rights of public in and to any portion of said premises lying within the limits of said roads and highways.
