WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, that PINEY WOODS LAND AND DEVELOPMENT CO., an Oregon Corporation, hereinafter called Grantor, for the consideration hereinafter stated, to Grantor paid by DANIEL J. DUFF and DORIS V. DUFF, husband and wife, hereinafter called Grantees, does hereby grant, bargain, sell and convey unto the said Grantees and Grantees' heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and the State of Oregon, described as follows, to-wit:

LOT 9, BLOCK 2, FIRST ADDITION TO KENO HILLSIDE ACRES, according to the Official Plat thereof on file in the office of the County Clerk of Klamath County, Oregon, filed June 28, 1977.

TO HAVE AND TO HOLD the same unto the said Grantees and Grantees' heirs, successors and assigns forever.

And said Grantor hereby covenants to and with said Grantees and Grantees' heirs, successors and assigns, that Grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except:

1. Rights of the public in and to any portion of the herein described premises lying within the limits of streets, roads or highways.
2. Right of Way to California Oregon Power Company, recorded June 28, 1926, in Volume 72, Page 48, Deed Records of Klamath County, Oregon (no location given).

3. Right of Way to Pacific Power and Light Company, a Maine Corporation, recorded January 21, 1966, in Volume M66, Page 604, Microfilm Records of Klamath County, Oregon.

4. Reservations, restrictions and easements, contained in the dedication and shown on the Plat of Tract No. 1121, First Addition, Keno Hillside Acres filed June 28, 1977, in the office of the County Clerk of Klamath County, Oregon.

5. Declaration of Protective Covenants and Restrictions, dated April 27, 1977, recorded June 15, 1977, in Volume M77, Page 10487, Microfilm Records of Klamath County, Oregon,





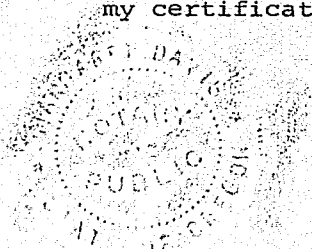
