Seller also agrees that when said purchase price is fully paid and upon request and upon surrender of this agreement, he will deliver a good and sulform deed convexing and premises in fee simple unto the buyer, his heirs and assigns, free and clear of encumbrances as of the date hereof and free and clear of all containances since said date placed, permitted or arising by, through or under seller, excepting, however, the said camends and restrictions and the laws, animospal liens, water tents and public charges so assumed by the buyer and further excepting all liens and encumbrances created by the buyer or his assigns.
