POWER OF ATTORNEY

to applications for Geothermal leases, offers to lease, bids, applications, Geothermal leases, permits, pooling agreements, cooperative and communitization agreements, plans of development, operating agreements, farmouts, dry-hole agreements, quitclaims and releases, rental and minimum royalty payments, rental and minimum royalty agreements, acquisitions and assignments of surface rights, Geothermal rights and interests, mineral rights and interests, water rights, servitudes and easements; and

2. To execute in the name of the Company such instruments and other documents as are necessary to carry out the powers granted the said CAREL OTTE hereunder; and

3. To represent the Company and appear before various Federal, state and other governmental bodies, agencies and organizations, to file statements and instruments in connection therewith and to make necessary statements and certifications concerning the Company and its activities, including statements of interest and of holdings that may be required by various Federal, state or other governmental laws or regulations.

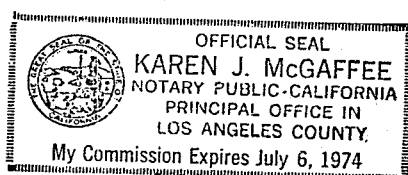
