## SHERIFF'S DEED

THIS DEED made December 6, 1978, between TOM DURYEE Sheriff of KLAMATH County, Oregon, hereinafter called Grantor and George H. Klotsas and Leah D. Klotsas , hereinafter called Grantee

## WITNESSETH:

WHEREAS, in a suit in the Circuit Court of the State of Oregon for KLAMATH County, Oregon, between Mike Deely and Jo Deely, husband and wife, Plaintiffs and George H. Klotsas, et al Defendants, a judgment and decree was entered on September 20, 1977, for the foreclosure of a mortgage on the real property described below; and

WHEREAS, the court thereafter issued a writ of execution and pursuant thereto on December 5, 1977, all of the interest of the Defendants in the real property was sold at public auction, subject to redemption, in the manner provided by law, for the sum of \$115,000.00 to Clement K. H. Lee, the highest bidder; and

WHEREAS, the sheriff, after receiving from the purchaser the sum of money so bid, duly executed and delivered to the purchaser a Certificate of Sale; and

WHEREAS, the sheriff then filed the return of sale with the court and an order confirming the sale was entered on December 22, 1977; and

WHEREAS, the Certificate of Redemption was issued August 4, 1978 and was entered August 9, 1978 in favor of George H. Klotsas and Leah D. Klotsas; and

WHEREAS, the time for redeeming as required by law has expired, the real property has not been again redeemed, and the Grantee herein is the owner and holder of the Certificate of Redemption,

NOW, THEREFORE, in consideration of the sum paid for the real property Grantor does hereby convey to Grantee all of the interest the defendants had on September 1, 1969, the date of the mortgage, and all interest which Defendants had thereafter in that real property described as attached, EXHIBIT "A", which is made a part hereof.

The true and actual consideration for this transfer is \$119,555.89.
