CONTRACT-REAL ESTATE

THIS CONTRACT, Made this 25th day of October Alfredo Quebedo and Linda A. Quebedo, husband and wife

and David Hamby and Roslyn Hamby, husband and wife, hereinatter called the seller,

, hereinafter called the buyer, WITNESSETH: That in consideration of the mutual covenants and agreements herein contained, the seller agrees to sell unto the buyer and the buyer agrees to purchase from the seller all of the following described lands and premises situated in Klamath County, State of Oregon to-wit: Beginning at the most Easterly corner of Lot 1 in Block 7 of FIRST ADDITION to the City of Klamath Falls, Oregon; thence Southwesterly at right angles to Eighth Street, 70 feet; thence Northwesterly parallel with Eighth Street, 55 feet; thence Northeasterly at right angles to Eighth Street, 70 feet; thence Southeasterly parallel with Eighth Street, 55 feet to the point of beginning, being a part of Lots 1 and 2 of Block 7 of FIRST ADDITION to Klamath Falls, Oregon.

Subject, however, to the following: 1. Taxes for the fiscal year 1978-79, a lien, but not yet due and pavable.

Recorded Contract, including the terms and provisions thereof, dated October 10th, 1978, recorded December 12, 1978 in Volume M78, page 27641, Microfilm Records of Klamath County, Oregon, between Elsie Sisson, Seller, and Alfredo Ouebedo and Linda A. Quebedo, husband and wife, Buyers, which Buyers herein do not assume and agree to pay, and Sellers further covenant to and with Buyers that (for continuation of this contract see reverse side of this Contract)

for the sum of Twelve Thousand and No/100ths------ Dollars (\$.12,000.00...) (hereinafter called the purchase price), on account of which one. Thousand Five Hundred and Dollars (\$1,500.00...) is paid on the execution hereof (the receipt of which is hereby acknowledged by the seller); the buyer agrees to pay the remainder of said purchase price (to-wit: \$10,500.00....) to the order of the seller in monthly payments of not less than Dollars (\$ 125.00) each, or more, prepayment without penalty,

payable on the 1St day of each month hereafter beginning with the month of December, 19.7.8, and continuing until said purchase price is fully paid. All of said purchase price may be paid at any time; all deferred balances of said purchase price shall bear interest at the rate of 9/2 per cent per annum from October 25 ,1978, until paid, interest to be paid monthly and * | in statistics to be paid monthly being included in the minimum monthly payments above required. Taxes on said premises for the current tax year shall be prorated between the parties hereto as of the date of this contract.
