KNOW ALL MEN BY THESE PRESENTS:

That I, DAVID ALLEN LINDSAY

a legal resident of the (town, city, or county) of Portsmouth
State of Virginia, United States of America, now in the Naval service as a
Commissioned Officer with the USNR and anticipating that I may be required to go
overseas in said service, have made, constituted and appointed, and by these presents do
make, constitute and appoint my wife, Karen Judy Lindsay

whose address is 3712 Pinebark Road, Portsmouth, Virginia 23703

my true and lawful attorney for a period of (10 months) ~~years~~ from the date of
this instrument, unless sooner revoked, to act in, manage, and conduct all my estate and
all my affairs, and for that purpose for me and in my name, place, and stead, and for my
use and benefit, and as my act and deed, to do and execute, or to concur with persons
jointly interested with myself therein in the doing or executing of, all or any of the follow-
ing acts, deeds, and things, that is to say:

- (1) To buy, receive, lease, accept, or otherwise acquire; to sell, convey, mort-
gage, hypothecate, pledge, quit claim, or otherwise encumber or dispose of; or to contract
or agree for the acquisition, disposal, or encumbrance of; any property whatsoever or
any custody, possession, interest, or right therein, upon such terms as my said attorney
shall think proper;
- (2) To take, hold, possess, invest, lease, or let, or otherwise manage any or all
of my property or any interest therein; to eject, remove, or relieve tenants or other per-
son from, and recover possession of, such property by all lawful means; and to maintain,
protect, preserve, insure, remove, store, transport, repair, rebuild, modify, or improve the
same or any part thereof;
- (3) To make, do, and transact all and every kind of business of what nature or
kind soever, including the receipt, recovery, collection, payment, compromise, settlement,
and adjustment of all accounts, legacies, bequests, interests, dividends, annuities, de-
mands, debts, taxes, and obligations, which may now or hereafter be due, owing, or pay-
able by me or to me.
- (4) To make, indorse, accept, receive, sign, seal, execute, acknowledge, and
deliver deeds, assignments, agreements, certificates, hypothecations, checks, notes,
bonds, vouchers, receipts, and such other instruments in writing of whatever kind and
nature as may be necessary, convenient, or proper in the premises;
- (5) To deposit and withdraw for the purposes hereof, in either my said attor-
ney's name or my name or jointly in both our names, in or from any banking institution,
any funds, negotiable paper, or moneys which may come into my said attorney's hands as
such attorney or which I now or hereafter may have on deposit or be entitled to;
- (6) To institute, prosecute, defend, compromise, arbitrate, and dispose of legal,
equitable, or administrative hearings, actions, suits, attachments, arrests, distresses or
other proceedings, or otherwise engage in litigation in connection with the premises;
- (7) To act as my attorney or proxy in respect to any stocks, shares, bonds, or
other investments, rights, or interests, I may now or hereafter hold;
- (8) To engage and dismiss agents, counsel, and employees, and to appoint
and remove at pleasure any substitute for, or agent of my said attorney, in respect to all
or any of the matters or things herein mentioned and upon such terms as my attorney
shall think fit;
- (9) To execute vouchers in my behalf for any and all allowances and reim-
bursements properly payable to me by the United States, including but not restricted to
allowances and reimbursements for transportation of dependents or for shipment of house-
hold effects as authorized by law or Naval regulations, and to receive, indorse, and collect
the proceeds of checks payable to the order of the undersigned drawn on the Treasurer of
the United States;
- (10) To prepare, execute, and file income and other tax returns, and other gov-
ernmental reports, applications, requests and documents;

(11) To take possession, and order the removal and shipment of any of my property from any post, warehouse, depot, dock, or other place of storage or safekeeping, governmental or private; and to execute and deliver any release voucher, receipt, shipping ticket, certificate, or other instrument necessary or convenient for such purpose.

GIVING AND GRANTING unto my said attorney full power and authority to do and perform all and every act, deed, matter, and thing whatsoever in and about my estate, property, and affairs as fully and effectually to all intents and purposes as I might or could do in my own proper person if personally present, the above specially enumerated powers being in aid and exemplification of the full, complete, and general power herein granted and not in limitation or definition thereof; and hereby ratifying all that my said attorney shall lawfully do or cause to be done by virtue of these presents.

And I hereby declare that any act or thing lawfully done hereunder by my said attorney shall be binding on myself, and my heirs, legal and personal representatives, and assigns whether the same shall have been done before or after my death, unless and until reliable intelligence or notice thereof shall have been received by my said attorney; and whether or not I, the grantor of this instrument, shall have been reported or listed, either officially or otherwise, as "missing in action" as that phrase is used in Naval parlance, or that I shall have been reported or listed, either officially or otherwise, as a prisoner of war, it being the intent hereof that such status designation as "missing in action" or "prisoner of war" shall not bar my attorney from fully and completely exercising and continuing to exercise any and all powers and rights herein granted, and that such report of "missing in action" or "prisoner of war" shall neither constitute or be interpreted as constituting notice of my death nor operate to revoke this instrument.
