WHEREAS, said contract provides, among other things, that upon payment of the sum of ONE HUNDRED EIGHTY THOUSAND AND NO/100 DOLLARS (\$180,000.00), Sellers will convey to Purchasers the above described real property by Warranty Deed;

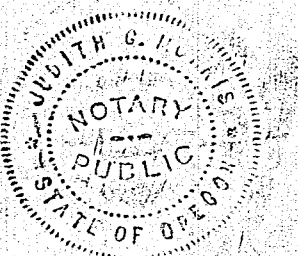
