## POWER OF ATTORNEY

## GENERAL

- (2) to contract for, purchase, receive, and take lands, interest in land of any kind and accept the possession of land;

- (4) to execute, acknowledge and deliver deeds, leases and assignments of leases, covenants, agreements and assignments of agreements, mortgages and assignments of mortgages, conveyances in trust to secure indebtedness or other obligations, bills of lading, bills, bonds, notes, receipts, evidences of debt, releases and satisfactions of mortgages, judgments, and other debts, and other instruments in writing of whatever kind of nature, all upon such terms and conditions and under such covenants as said attorney shall approve.

GIVING AND GRANTING to said Attorney full power and authority to do and perform all and every act and thing whatsoever requisite and necessary to be done relative to any of the foregoing as fully to all intents and purposes as Principal might or could do if personally present.


