KNOW ALL MEN BY THESE PRESENTS, That Elmer R. Walker

hereinafter called the grantor, for the consideration hereinafter stated to the grantor paid by Arthur Lee Rasmussen and Marilyn C. Rasmussen, husband and wife, hereinafter called the grantees, does hereby grant, bargain, sell and convey unto the grantees, as tenants by the entirety, the heirs of the survivor and their assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath, State of Oregon, described as follows, to-wit: Lot 2, Block 2, SHASTA VIEW TRACTS, according to the official plat thereof on file in the office of the County Clerk, Klamath County, Oregon.

Subject, however, to the following:

1. Taxes for 1978-79 are now a lien, but not yet payable.
2. Rules, regulations and assessments of South Suburban Sanitary District.
3. Assessments and charges of the City of Klamath Falls for monthly water and/or sewer service.

grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
