Corzatt; thence S. 18 deg. 59' E. a distance of 640.2 feet to a point; thence S. 40 deg. 11' E. a distance of 387.8 feet to a point; thence S. 27 deg. 58'20" E. a distance of 704.35 feet to a point; thence S. 82 deg. 57'20" E. a distance of 831.95 feet to a point; thence S. 32 deg. 08'20" E. a distance of 633.45 feet to a point; thence S. 70 deg. 52'40" E. a distance of 384.8 feet to a point; thence S. 20 deg. 04'40" E. a distance of 363.0 feet to a point on the North line of the SW 1/4 SE 1/4 of said Section 33; thence West along said North line and along the North line of the SE 1/4 SW 1/4 to the Northeast corner of the SW 1/4 SW 1/4 of said Section 33; thence South along the East line of said SW 1/4 SW 1/4 to the South line of said Section 33; thence West along the South line of said Section to the Southwest corner thereof; thence North along the West line of said Section 33 to the point of beginning.
