WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS, That Carson S. Kendall and Sharon A. Kendall, husband and wife,

hereinafter called the grantor, for the consideration hereinafter stated, to grantor paid by Washburn Enterprises, Inc., an Oregon Corporation,

the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

PARCEL 1

A parcel of land situate in the SW $\frac{1}{4}$ SE $\frac{1}{4}$  of Section 1, Township 39 South, Range 9 East of the Willamette Meridian, more particularly described as follows:

Beginning at the Southeast corner of said SW $\frac{1}{4}$ SE $\frac{1}{4}$ ; thence North 0°27' West 77.7 feet to the true point of beginning; thence North 46°07' West 226 feet to a point; thence North 43°00' East 133.0 feet to a point; thence East along the South line of parcel of land described in deed Vol. M67, page 10096, to the East line of said SW $\frac{1}{4}$ SE $\frac{1}{4}$ ; thence South along said East line to the point of beginning.

SAVING AND EXCEPTING therefrom that portion thereof conveyed to the State of Oregon, by and through its Department of Transportation, Highway (For continuation of this document, see reverse side of this deed.)

To Have and to Hold the same unto the said grantee and grantee's heirs, successors and assigns forever.

And said grantor hereby covenants, to and with said grantee and grantee's heirs, successors and assigns, that grantor is lawfully seized in fee simple of the above granted premises, free from all encumbrances except as noted of record as of the date of this deed and those apparent upon the land, if any, as of the date of this deed,

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.

The true and actual consideration paid for this transfer, stated in terms of dollars, is \$21,000.00
