WITNESSETH: That in consideration of the mutual covenants and agreements herein contained, the seller agrees to sell unto the buyer and the buyer agrees to purchase from the seller all of the following de-County, State of scribed lands and premises situated in Klamath Oregon

The buyer shall be entitled to possession of said lands on . Closing . 1978, and may retain such possession so long as he is not in default under the terms of this contract. The huyer agrees that at all times he will keep the buildings on said premises, now or hereafter erected, in good condition and repair and will not suffer or permit any waste or strip thereofs that he will keep said premises tree from mechanic's and all other liens and save the seller harmless therefrom and reimburses seller for all costs and attorney's lees incurred by him in detending against any such here; that he will pay all taxes hereafter levied against said promptly, as well as all water rents, public charges and municipal liens which hereafter lawfully may be imposed upon said premises, all promptly before the same or any part thereof become past due; that at huyer's expense, he will insure and keep insured all buildings now or hereafter erected on said premises against loss or damage by fire (with extended coverage) in an amount

not less than \$1.1,000 * 00 in a company or companies satisfactory to the seller, with loss payable first to the seller and then to the buser of their respective interests may appear and all policies of insurance to be delivered to the seller as soon as insured. Now if the buser shall full to pay any such liens, costs, water rents, taxes, or charges or to procure and pay for such insurance, the seller may do so and any payment so made shall be added to and become a part of the debt secured by this contract and shall bear interest at the rate aforesaid, without waver, however, of any right arising to the seller for buyer's breach of contract.

The seller agrees that at his expense and within 30 days from the date hereot, he will furnish unto buyer a title insurance policy to suring (in an amount equal to said purchase price) marketable title in and to said premises in the seller on or subsequent to the date of this agreement save and except the usual printed exceptions and the building and other restrictions and easements now of record, if any Seller also agrees that when said purchase price is fully paid and upon request and upon surrender of this agreement, he will deliver a good and sufficient dead convexing said premises in the simple unto the buyer, his heirs and assigns, three and clear of encumbrances as of the date hereof and tree and clear of all remaintances since said date placed, permitted or arising by, through or under seller, excepting, however, the said easements and restrictions and the taxes, manufold liens, water rents and public charges so assumed by the buyer and further excepting all liens and encumbrances created by the buyer or he assigns.
