KNOW ALL MEN BY THESE PRESENTS, That Earl E. Darrow and Kenneth , hereinafter called grantor, for the consideration hereinafter stated, does hereby grant, bargain, sell and convey unto Kenneth W.

Darrow and Janice L. Darrow, husband and wife, hereinafter called grantee, and unto grantee's heirs, successors and assigns all of that certain real property with the tenements, hereditaments and appurtenances thereunto belonging or in anywise appertaining, situated in the County of Klamath , State of Oregon, described as follows, to-wit:

## MIDDLE PARCEL:

A tract of land situated in the S½N½NW¼NE¾ of Section 16, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at a point on the West line of said Sananwane (Hereinafter referred to as "parcel") from which the Southwest corner thereof lies Southerly 150 feet; thence 1st, Easterly, parallel to the South line of said parcel, 320.4 feet to a point; thence 2nd, Southerly, parallel to the West line of said parcel, 150 feet to a point on the South line of said parcel, said point being 320.4 feet Easterly of the Southwest corner of said parcel; thence 3rd, Easterly along said South line 421.4 feet to a point; thence 4th, Northerly parallel to the West line of said parcel, 330 feet, more or less, to the North line thereof; thence 5th, Westerly, along said North line, 742 feet, more or less to the Northwest corner of said parcel; thence 6th, Southerly, along the West line of said parcel, to the point of beginning.
