

A strip of land 100.00 feet wide over and across the Southeast Quarter of the Southeast Quarter of Section 11, Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, lying 30 feet Westerly and 70 feet Easterly of and at right angles to the following described centerline:

Commencing at the Northwest Corner of the Southeast Quarter of the Southeast Quarter of Section 11, Township 41 South, Range 12 East W. M., said corner being marked with a fence intersection; thence N 89°14'54" E, along the Northerly boundary of said parcel, a distance of 459.75 feet to the true point of beginning; thence S 20°33'04" E, a distance of 1381.81 feet to the terminus point on the Southerly boundary of said Section 11, said point being S 89°31'15" W, a distance of 391.06 feet from the computed Southeast Corner of said Section 11.

The above described easement contains 3.17 acres, more or less.
