NOTICE OF LOCATION AMENDING DESCRIPTION OF EXISTING RIGHT OF WAY

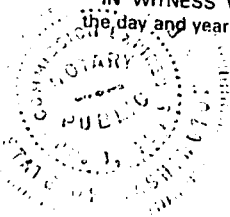

EXHIBIT "A"

A strip of land 100.00 feet wide over and across the Northeast Quarter of the Northeast Quarter of Section 14, Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, lying 30 feet Westerly and 70 feet Easterly of and at right angles to the following described centerline:

Commencing at the Northwest Corner of the Southeast Quarter of the Southeast Quarter of Section 11, Township 41 South, Range 12 East W.M., said corner being marked with a fence intersection; thence N 89°14'54" E, along the Northerly boundary of said parcel, a distance of 459.75 feet; thence S 20°33'04" E, a distance of 1381.81 feet to the true point of beginning on the Northerly boundary of the Northeast Quarter of the Northeast Quarter of Section 14, Township 41 South, Range 12 East W.M., said point being S 89°31'15" W, a distance of 391.06 feet from the computed Northwest Corner of said Section 14; thence continuing S 20°33'04" E, a distance of 1158.18 feet to the terminus point on the Easterly boundary of said Section 14, said point being N 00°49'03" W, a distance of 266.86 feet from the Southeast Corner of said parcel, said corner being marked with a road intersection.

The above described easement contains 2.66 acres, more or less.
