A strip of land 100.00 feet wide over and across the South Half of the Northeast Quarter of the Northwest Quarter and a portion of the Southeast Quarter of the Northwest Quarter of Section 24, Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, lying 30 feet Westerly and 70 feet Easterly of and at right angles to the following described centerline;

Commencing at the Northeast Corner of the Southwest Quarter of the Southwest Quarter of Section 13, Township 41 South, Range 12 East W.M., said corner being marked with the intersection of the centerline of a road and a projected fence line; thence S 89°41'42" W, along the Northerly boundary of said parcel, a distance of 670.56 feet; thence S 18°40'23" E, a distance of 505.53 feet; thence S 25°29'17" E, a distance of 1664.16 feet to the true point of beginning on the Northerly boundary of the South Half of the Northeast Quarter of the Northwest Quarter of Section 24, Township 41 South, Range 12 East W.M., said point being N 89°23'35" E, a distance of 224.28 feet from the computed Northwest Corner of said parcel; thence continuing S 25°29'17" E, a distance of 2206.36 feet to the terminus point on the Southerly boundary of the Southeast Quarter of the Northwest Quarter of said Section 24, said point being S 89°09'22" W, a distance of 175.60 feet from the Southeast Corner of said parcel, said corner being marked with a fence corner.

The above described easement contains 5.07 acres, more or less.
