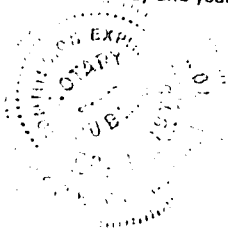

A strip of land 100.00 feet wide over and across that part of the Northeast Quarter of the Southwest Quarter and that part of the Northwest Quarter of the Southeast Quarter lying Northerly and Easterly of the Old Dalles-California Highway in Section 24, Township 41 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon, lying 30 feet Westerly and 70 feet Easterly of and at right angles to the following described centerline:

Commencing at the Northeast Corner of the Northeast Quarter of the Southwest Quarter of Section 24, Township 41 South, Range 12 East W. M., said corner being marked with a fence corner; thence S 89°09'22" W, along the Northerly boundary of said parcel, a distance of 175.60 feet to the true point of beginning; thence S 25°29'17" E, a distance of 733.52 feet to the beginning of a curve to the Right with a central angle of 11°05'34", a radius of 205.96 feet, a tangent of 20.00 feet and an arc distance of 39.87 feet; thence, from the end of the curve, S 14°23'43" E, a distance of 106.38 feet to the terminus point on the Southerly boundary of said Section 24 and the State Line of Oregon and California, said point being N 89°32'24" W, a distance of 2449.37 feet from the Southeast Corner of said Section 24, said corner being marked with a railroad spike.

The above described easement contains 2.02 acres, more or less.
