The Northwest one-quarter of the Northwest one-quarter (NW $\frac{1}{4}$ of NW $\frac{1}{4}$); The Northeast one-quarter of the Southwest one-quarter (NE $\frac{1}{4}$ of SW $\frac{1}{4}$); The Northwest one-quarter of the Southwest one-quarter (NW $\frac{1}{4}$ of SW $\frac{1}{4}$); all in Section 36, Township 24 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon.

Subject to:

1. Rights of the public in and to any portion of the herein described premises lying within the limits of streets, roads, or highways.
2. Subject to an easement for a power line as disclosed by Klamath County Assessors Map.
