KNOW ALL MEN BY THESE PRESENTS, That P.K. PUCKETT and BETTY C. PUCKETT, husband and wife,

JONES, JR., and CONSUELO JONES, husband and wife, the grantee, does hereby grant, bargain, sell and convey unto the said grantee and grantee's heirs, successors and assigns, that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or appertaining, situated in the County of Klamath and State of Oregon, described as follows, to-wit:

Lots 7, 8 and 9, Block 14, MOUNTAIN VIEW ADDITION to the City of Klamath Falls, Oregon.

SUBJECT TO: All future real property taxes and assessments; reservations, restrictions, easements and rights of way of record, and those apparent on the land; existing and future liens of the City of Klamath Falls for street improvements and otherwise, which Grantees assume and agree to pay.
