of Klamath, State of Oregon, described as follows, to-wit: (legal description attached)A tract of land situated in Sections 2 and 3, T.35 S., R.11 E., of  
the W.M., in the County of Klamath and State of Oregon described  
as follows:Beginning at the Northwest corner of said Section 2, thence South  
88°59'04" East along the Northerly line of said Section 2, a distance  
of 276.30 feet to an intersection with the centerline of an existing  
Indian Service Road; thence South 33°06'52" West along the centerline  
of said road, a distance of 35.00 feet to the true point of beginning  
of the tract of land herein to be described; thence South 59°41'57"  
East a distance of 1375.68 feet to the most Northerly corner of a  
tract of land described in a Contract to FAJO INC., Recorded November  
3, 1977 in Volume M-77, Page 21083, Deed Records; thence South  
28°30'24" West along the Westerly line of FAJO, INC., tract a distance

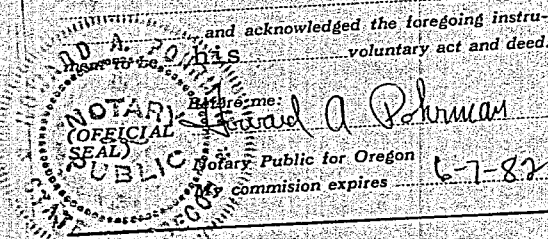
