KNOW ALL MEN BY THESE PRESENTS, That CALVIN HOO AND JANE HOO

Lots 4, 5, 6 Block 2 BUENA VISTA ADDITION to the City of Klamath Falls, Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Subject to reservations, restrictions, rights of way of record, if any and those apparent upon the land; Assessments and charges of the City of Klamath Falls, for monthly water and/or sewer, if any.

and that grantor will warrant and forever defend the said premises and every part and parcel thereof against the lawful claims and demands of all persons whomsoever, except those claiming under the above described encumbrances.
